Applications are invited from the eligible candidates of Himachal Pradesh **on or before 30.09.2019** for Combined Screening Test for the post of Patwaris Candidates in Mohal and Settlement Departments, who will be appointed on the terms and conditions of Government of Himachal Pradesh on contract basis after qualifying the examination and successful completion of training as per the availability of posts of Patwaris.

### **1. Essential Educational Qualification:-**

- (a) Candidates should have passed 10+2 examination or its equivalent from a recognized Board of School Education/University.
- (b) The candidates appearing in sports category should be National level medal winner or who have participated three time in National level tournament.
- (c) Candidates belonging to reserved category shall have to submit proof that he/she belongs to reserved category (to be attached with application form)

### **(ii) Desirable Qualification:-**

Knowledge of customs, manners and dialects of Himachal Pradesh and suitability for appointment in the peculiar conditions prevailing in the Pradesh.

2. **Age** Between 18 and 45 year as on 1.1.2019 (Upper Age limit for SC, ST & OBC categories will be 50 years)
