#### **Terms & Conditions:**

- i) Initially each consultant may be appointed for a period of one year on contract basis which may be extended year to year of satisfactory performance of duties.
- ii) The remuneration allowed to such consultants shall in no case be more than the last pay drawn minus pension.
- iii) These consultants shall only be appointed for performing clinical duties and shall in no case be assigned any administrative duties.

- iv) The maximum age for appointment of consultant for a period of one year shall be 64 years and under no circumstances shall a consultant will be retained upon attaining the age of 65 years of age.
- v) The consultant shall not be allowed to carry out private practice during such time that they are on contract with the Government.
- vi) The engagement of the consultant shall be strictly on contractual basis and other terms and conditions shall be regulated as per the guidelines of the Finance Department issued from time to time in this regard.
- vii) It will be strictly non-transferable.
- viii) Station to be allotted on merit basis.
- ix) Details of posts/ Speciality with station may be mentioned at website. Candidate to give preferences of station in their application.
- x) Age limit: Between 58 and 64 years as on the last date of receipt of applications.

**Note:** Candidates appearing before the interview selection committee should come with their original certificates/ testimonials on the day of interview.

- 1. It is mandatory for all candidates to bring their all original certificates at the time of interview. Candidate who will not bring his/her original documents will not be interviewed.
- 2. No TA/DA will be paid for the journey performed for the interview etc.
